Sub: Decision to change the category of schools run by the society created by the different Ministry/Department/Govt.Body/Undertaking and Regularization of Affiliation Period w.e.f. 01.04.2007 to 31.03.2022- req.

Sir/Madam,

With reference to the subject cited above it is informed that under chapter-II of revamped Affiliation Bye-Laws-2018, the Board categorized its affiliated schools all over India and abroad from rule no. 2.1.1 to 2.1.10

Schools falling under purview of rule 2.1.1, 2.1.2, 2.1.3 and 2.1.4 are placed under regular Affiliation. Therefore, in the light of the above decision, I am directed to inform you that North Eastern Railway Sr. Sec. School, Kawabagh Colony, Gorakhpur Uttar Pradesh -237001 school managed by Ministry of Railways affiliated vide Affiliation No. 2130047 now stands affiliated under regular category with

New Affiliation No.2180050

Accordingly, the school would now quote the above New Affiliation No.2180050 in its all future correspondence including in all the school records alongwith the old Affiliation No. 2130047 for further period of two years so that it can be co-related instantly. After two years, the school can quote only new affiliation No. allotted to it.

It is further, clarified that the concerned Ministry/Department/Govt. Undertaking/Society created by such Deptt./organisation which is running the school, shall now be responsible to develop and adopt well defined rules including service rules in confirmatory to State/U.T/Centre Education Act/Affiliation Bye-Laws of the Board to govern the day today administration of the school. It is also the responsibility of the Management to notify the rules so adopted by it for the general information of all concerned.

Further it is informed that as per records available with the Board, the School was Granted extension by the Board w.e.f. 01.04.2012 to 31.03.2017 under Independent category and after that the School has applied for Extension for Affiliation in session 2017-18 vide online application no. EX-00521-1819 dated 30.01.2017 alongwith requisite fee of Rs. 35,000/- (including Penalty amount of Rs.10,000/- for late submission of online application for Extension of Affiliation under independent category). Therefore, to regularize the School Affiliation Period upto Sr. Secondary level w.e.f.
